

## Endsleigh Loop Reward Scheme (the 'Reward Scheme') – Terms and Conditions

2. To be eligible for a Reward you must:
  - a. be a current Endsleigh Loop policyholder,
  - b. have driven at least 40 miles over a period of 10 days with the Endsleigh Loop telematics device enabled,
  - c. have achieved a driving score of 60 or more and
  - d. not have received a **black message** in the current quarter.
3. **The Reward: £10 Amazon E- Voucher.** Endsleigh reserves the right to provide a substitute Reward of similar value should the Reward become unavailable for reasons beyond its control.
4. The Reward Scheme is open from 2<sup>nd</sup> July 2020 until further notice.
5. Entrants must have complied with all terms of their Endsleigh Loop insurance policy to be eligible for a Reward.
6. By purchasing an insurance policy from Endsleigh Loop, the policyholder will be deemed to accept these Terms and Conditions and those of any relevant third party.
